AN OPEN LETTER from DIRECTING BUSINESS REP JIM BENO



LOCAL 1414 MUNI techs teach high schoolers to weld

Local 1414 worked hard to develop a summer internship program with the San Francisco Unified School District and MUNI, but it was up to members Bill Wallace and Ron Curly to create projects that would keep the students busy and learning for five weeks over the summer. Ultimately, three days a week, the students came to the Woods MUNI facility to work with the IAM members and get hands-on machine shop experience.

The project included precise measuring, learning to cut the metal with a chop saw, TIG welding all the parts together, using an angle grinder to clean and polish the metal

and finishing with a clear coat of paint. "The students

were very proud of the finished project and thrilled that they experienced and learned welding," says Rich Del Rosso, a Local 1414 member who oversaw the program and provided the classroom instruction that accompanied the hands-on work.

First contract at Storer

weld in a summer program at MUNI.

Once they ratified their first contract on October 2, the two techs at Storer Transit Systems in Hayward officially became members of Local 93. Welcome and congratulations!

The techs won an organizing election and received certification in July. Business Rep/Organizer Pedro Gonzalez started negotiations for a first contract immediately thereafter.

The employer's final offer provides the members with wage increases of 16% or \$3.93/hour the first year, with increases of \$2.24 each of the next three years, and \$0.67/hour in the fifth year. This brings the wages from \$31.50 up to \$41.18 by the end of the contract term, with the possibility of earning more after completing ASE certifications. The employer agreed to pay \$727 toward health and welfare costs, and will keep the same percentage in any future contracts they renegotiate with the school district. Other improvements include a more generous paid-time-off policy, additional sick leave, and allowances for safety glasses, boots, and other PPE.

Increases at Granite Rock

Business Rep Richard Breckenridge reports that the 18 members who work at Granite Rock in Aromas ratified a new four-year agreement that includes wage increases of \$2.20 in the first and second year, and \$2.25 in the third and fourth year.

LOCAL 801

Better than expected

"You could have knocked me over with a feather getting this contract with LB&B Associated," says Area Director Mark Martin. "Effective next year, the company will make a meaningful contribution to the IAM National Pension Plan for our members, and the 2.7% wage increases each year were also pretty significant." The agreement was ratified unanimously.

LOCAL 1173

New deals in Concord

The 60 members who work at Concord Toyota and Concord Honda, both Sonic-owned dealerships, ratified new three-year contracts.

"We 'Armor-Globed' the Service Writers into Concord Honda and now they're rolled into the union," reports Area Director Steve Older. This is a process where non-union employees who sign union cards can be brought into an otherwise union setting, without needing a full NLRB election. The contracts include wage increases of \$1/hour in year one, and \$0.50/hour in years two and three.

"Importantly, instead of giving a percentage increase, which favors the higher-paid employees, these contracts offer the same wage across the board. This brings up the lowerwage folks more," Older explains. "In addition to a vacation boost, Sonic also gave a longevity bonus for employees who have been there for more than 10 years."

Almost done at Winter Chevrolet

Just before Labor Day and after the contract had already expired, Winter Chevrolet brought in the anti-union law firm, Littler Mendelson, to offer a measly \$0.50/hour increase.

"The guys voted to walk," says Business Rep Brian Fealy. "The company came up to \$.70/hour, which wasn't enough, so the members took to the streets for nearly three hours. In that time, we got them up to \$1.10, with three sick days and some retro pay." Fealy is finishing up the last details now.

Another dealership

Older negotiated the contract for

Cole European in Walnut Creek and the 30 techs, parts department, and Teamsters ratified it. The three-year contract calls for wage increases of \$2.50/hour in year one, and then \$1/ hour in years two and three.

Boilermakers staff

The staff for the Boilermakers office and Training Trust ratified their new contract.

LOCAL 1414

Good deal despite the odds

Somehow, the members at Puglia Engineering, a ship repair company in San Francisco, got 3% wage increases for the next three years in their new contract. "The company bought the dry-docks for \$1 and assumed the pension liability, which was sizable," says Older. "But now their parent company is bankrupt. We hope they find a way to keep going."

LOCAL 1528

Won't sign off

In May, Local 1528 reached an agreement with Silgan for a new contract "but, to date, the company hasn't signed off on it," says Mark Martin. "We may have to file a charge with the Labor Board. In all my years on staff, I've never faced such difficulty in getting a contract signed."

LOCAL 1546

NLRB rules again for IAM against ILWU

For the past 14 years, the IAM has been in various courts challenging a slew of employers and the Longshoremen's (ILWU) Union for the right of IAM techs to maintain their union of choice and work at the port of Oakland. In the latest case against Everports, the judge ruled for the IAM on every point. "She declared that the employer actively colluded

with the ILWU to displace and replace our workforce," says Area Director Don Crosatto.

"The judge ruled that the employer must offer employment to any of our members who weren't hired; repudiate the ILWU contract with regard to mechanics; make everybody whole for lost wages, with interest; make the benefit plans whole for contributions not made; and bargain a new contract with the IAM," Crosatto adds.

Not surprisingly, Everports and the ILWU chose to appeal to the full labor board. "In this case, both sides file briefs, there's no court hearing," Crosatto explained. "The last of the briefs are due by the end of November. Some time after that, the Board will render a decision on the appeal." During that time, nothing changes, other than the employer's liability for all the back pay and costs.

Finally, in Alaska

After a year of complicated negotiations, the 11 members at PBA Maintenance in Alaska ratified a new threeyear contract. The hold-up was the amount of overtime the mechanics are working and the employer's desire to limit the amount of double-time. "We were convinced that they would not cut the amount of work, which has averaged 80-100 hours/week," says Crosatto. "It was more likely that people would work the same number of hours but just for less money." The employer finally agreed to leave the double-time alone and hire five more people.

The hourly wage-rate is now at

\$43.50, with \$0.25/hour more going into the IAM National Pension Plan, and the employer will cover the cost of the health and welfare increase.

A new waterfront deal

The members at SSA Terminals ratified a new 5-year agreement, that includes increases of \$1.25/hour for the first two years, and \$1.50/hour for the final three, for a total of \$7 in wage increases. At end of contract, the day shift wage-rate will be \$55.30.

The employer will contribute an additional \$5/hour into the National Pension Plan, taking that to \$11.15/hour. "The guys voted down the first two offers. They only agreed to ratify when we got them an additional floating holiday," Crosatto says.

Meeting the high bar

On September 29, the 75 members at Waste Management who work at several facilities across Alameda County ratified a new three-year contract.

"The guys held strong and voted down an inferior offer," says Area Director Don Crosatto. "The Teamsters, who negotiate their contract before the IAM does, set a high bar that we strove to meet. We succeeded."

The members will get a cost of living increase of 3.6%/year. The wagerate for day shift workers goes up to \$42.99, while the cost of health insurance dropped by half. The employer will put \$300/month into the 401K plan in the first year, increasing the contribution to \$425 and \$500/month each year. They'll kick-start it with \$500 in lieu of retro pay.

"This totals \$15,000 over four years," adds Crosatto. "On top of that, they get two more sick days, and improvements in the vacation schedule."

Welcome enviro techs

After a four-year effort, the three environmental techs at the West Contra Costa Sanitary Landfill/Republic Services, can join the IAM bargaining unit.

"Everybody else at this location is union, including the office staff, and they have been for decades," says Crosatto. "We thought that getting these three guys into the union would be a slam-dunk. Boy, were we wrong!"

Now that they're in the union, they'll be able to save hundreds of dollars each month on the medical plan alone, and the company will put \$275/month into their 401K. They'll also get retiree medical coverage and an extra holiday. "It pays to be union," says Crosatto.

Not ready for Safeway

At press-time, the members at Safeway voted down the company's offer. "We're working through some language issues," says Steve Older. "The company wants to institute time studies and the members oppose this more strongly than I had anticipated."

Another reject

Older reports that the techs at Hayward Honda voted down their latest contract offer. "We're working through the issues. They have a lower pay rate than the other Sonic stores and they're looking for parity."

LOCAL 1584

Taking on the Koch Brothers

Brian Fealy is in negotiations with GP Gypsum—a Koch Bros. company. "The talks have been going on for a while. Just as we were finishing up, the company threw in an 'alternative health care program,' throwing everything into a tizzy," says Fealy. "Stay tuned."

LOCAL 1596

More contracts

The two members at Chuck's Wheel & Brake in Santa Rosa have a new contract.

The 25 members at Donal Machine in Petaluma ratified a new five-year contract in September. "The members will see wage increases of \$1.25/ hour in the first two years of the contract, and CPI raises with a 4.5% cap for the following three years," reports Steve Older.

LOCAL 2182

New contract at Teichert

The members at Teichert in Sacramento recently ratified their new four-year contract. The Company agreed to absorb the entire cost of this year's health and welfare increase. "We were also successful in improving other language, including increasing the boot allowance," says Mark Martin.
