

# Vaccine mandates and the future of COVID

The COVID-19 pandemic has proven to be a test, not only of employers and unions and how well each are able to protect the workers they employ or represent, but also of the general public and the front-line workers themselves. While more than 700,000 Americans have fallen to the virus since March 2020, and the economy has likely forever been changed, IAM members have proven to be resilient.

It is surely everyone's goal to truly have the pandemic behind us. With over 77% of Americans over 12 years old at least partially vaccinated, the majority clearly agree that vaccinations are our best hope to beating back the virus.

### **Vaccine mandates ordered**

The Biden administration met its goals of making the vaccines free and widely available at more than 80,000 locations across the country, including over 40,000 retail pharmacies. Ninety percent of Americans live within five miles of a vaccine site.

As of this writing, the numerous Biden Administration initiatives and policies have resulted in nearly 190 million fully vaccinated Americans. But nearly 65 million Americans eligible to be vaccinated have not yet gotten their first shot.

While the administration was initially optimistic that vaccine rates would increase without mandates, the more contagious Delta variant led to a spike in cases at the same time vaccination rates started to decline.

In September, President Biden ordered the U.S. Labor Department's Occupational Safety and Health Administration (OSHA) to develop an Emergency Temporary Standard (ETS) requiring employers with 100 or more employees to ensure



their workforce is fully vaccinated or require unvaccinated workers to produce a weekly negative COVID-19 test result. Those working for federal contractor must be fully vaccinated no later than December 8, 2021. The only exemptions are for people with sincerely-held religious beliefs or medical exemptions, which the employer will approve or not on an individual basis.

Now that the question of whether to require vaccinations is settled, employers face a long list of questions about how to implement the mandate and unions must weigh in to ensure that it's done fairly.

#### The role unions play

While unions will not determine whether or not a vaccine mandate gets implemented, they are required to bargain about how it's administered:

- Do workers get paid time off to get the vaccine —for themselves and/or for their kids?
- Is there sufficient notice for how much time a worker has before penalties, such as going on leave or being fired, kick in?
- What is the process for recording that employees have been fully vaccinated and safekeeping

vaccination rate jumped 34% after the Governor announced requirements for state workers.

San Francisco's vaccine mandate will be fully implemented as of November 1. While the vast majority of IAM members who work for the City and County are vaccinated, those who hold ou risk their future employment status with the City.

The OSHA standard is expected to include a stipulation that employers must provide paid time off for employees to get vaccinated. This applies to both the public and private sectors. "No one should lose pay in order to get vaccinated or take a loved one to get vaccinated," Biden said.

### **Consequences for violating the rules**

Most Americans support vaccine mandates in workplaces, with 62% of Americans backing the idea, according to an August poll by USA Today and Ipsos. Still, among the 29% of U.S. voters who are unvaccinated, 83% say they do not plan to get the lifesaving shots, a recent CNBC survey shows.

Employees who fail to comply with the new mandates could face a range of consequences, including termination, as companies feel pressure

the privacy of that information?

On a national level, the IAM says it will closely examine OSHA's final rule and its full effect on different industries and employers. "The IAM places the highest priority on the health and safety of our members at all times," said IAM International President Robert Martinez Jr. "We continue to demand that employers provide personal protective equipment, practice social distancing and follow all CDC guidelines to ensure the safety and health of our members during this pandemic."

As one health advocacy organization stated to employers, "Getting vaccinated is an individual choice that you should respect — even if it means an employee cannot continue working for you."


According to *Forbes Magazine*, after United Airlines announced its vaccination requirement, more than half of its unvaccinated employees went out and got vaccinated with weeks left to go before the deadline. In Washington State, the weekly to fall in line.

Speaking at the White House, Biden sharply criticized the tens of millions of Americans who are not yet vaccinated, despite months of availability and incentives. "This is not about freedom or personal choice. It's about protecting yourself and those around you," he said.

In a statement, California's Employment Development Department (EDD) which is in charge of unemployment insurance, said benefits are generally only available to those "who lose work through no fault of their own." Because the mandate is coming from the government, and not from employers, it would be hard for workers to argue that they were fired by their boss and therefore eligible to receive unemployment insurance. "Once the vaccine mandate goes on the federal level, I don't think an employee can say it's employer's choice, not mine," explained an EDD representative.

# Absentee Ballot Procedure for District and Local Lodge Elections

As per the IAM Constitution, members who reside in outlying areas more than 25 miles from the designated balloting place, members who are at work during the times of the local lodge balloting, members who are either confined because of illness or injury, or on leave qualifying under U.S. and Canadian family leave laws, or working members on vacation, retirees more than 25 miles away from their residence on election day, or on official I.A.M. business approved by the Local, District or General Lodge, or on an employer travel assignment, or reserve military leave, as the case may be, shall be furnished absentee ballots.

Members applying for an absentee ballot on the basis of residing in an outlying district more than 25 miles from the designated balloting place shall have their eligibility to vote by absentee ballot determined by the Recording Secretary of the Local Lodge before the ballot is mailed. Members found not to be eligible to vote by absentee ballot will be so notified within 10 days of the receipt of their application. Before the absentee ballots are opened and counted, the inspectors of election shall determine the eligibility of the member to vote by the method, as defined in this Section, with the exception cited above.

Any member entitled to receive an absentee ballot shall make written request therefore to the Recording Secretary of the Local Lodge for the Local election by delivering in person or mailing such request to be received by the appropriate officer no later than 30 days before the election. The request must contain the member's full name, current address and one of the reasons for requesting the absentee ballot, as outlined above.

# **Strike-tober**

"A record 4.3 million Americans quit their jobs in August alone while hundreds of thousands of workers with similar grievances about wages, benefits and quality of life are choosing to fight. In October, 10,000 John Deere workers went on strike, while unions representing 31,000 Kaiser employees authorized walkouts. Some 60,000 Hollywood production workers reached a deal with producers, averting a strike hours before a negotiation deadline. All told, in 2021, there have been strikes against 178 employers, 12 of which involved 1,000 or more workers."
